

The Rolling River School Division

By-Law No. 1/2018

BEING A BY-LAW of the Board of Trustees of the Rolling River School Division to establish the boundaries of the wards and the number of trustees of the Division.

WHEREAS Section 57 (1) of The Public Schools Act provides as follows:

“Subject to subsections (2), (3), (4), (5) and (6) a school board may, by by-law, or on the petition of 10 or more resident voters

- (a) alter the boundaries of existing wards;
- (b) increase or decrease the number of wards;
- (c) increase or decrease the number of trustees in any ward but the total number of trustees shall not be fewer than five or more than 9;
- (d) repealed, S.M. 2002, c. 8, s. 15;
- (d.1) subject to section 57.1 abolish the existing wards and, establish the number of trustees to be elected at large, which must not be fewer than five or more than nine;
- (e) establish wards and subject to clause (c), state the number of trustees to be elected in each ward so established; or
- (f) do any one or more of the things mentioned in clauses (a) to (e).”

AND WHEREAS the legal description of the land contained within the boundaries of the Division is set forth in Manitoba Regulation 109/93, and as amended from time to time;

AND WHEREAS it is required that the Division define the boundaries of existing wards;

AND WHEREAS it is required that the Division state the number of trustees to be elected in each ward;

AND WHEREAS the Rolling River First Nation is established as a separate and additional Ward as set forth in Manitoba Regulation 173/2004;

NOW THEREFORE the Board of Trustees of the Rolling River School Division enact as follows:

- 1) THAT the Division be comprised of 4 Wards as described in Schedule A, attached and an additional Ward comprised of the Rolling River First Nation reserve status lands.
- 2) THAT the number of trustees elected in the said Division be as follows:


Ward One	1 Trustee
Ward Two	1 Trustee
Ward Three	2 Trustees
Ward Four	1 Trustee
Rolling River First Nation Ward	1 Trustee
- 3) THAT the term of office for trustees be four years.

- 4) THAT this By-Law be effective and in full force and effect as and from the 24th Day of October, A.D. 2018, as provided for under Section 57 (9) of The Public Schools Act.
- 5) THAT upon this By-Law coming into force, By-Law No. 1/2010 be and is hereby repealed.


